The evidence supported defendant's conviction for kidnapping when he drove the victim with a knife to the nearest police station to report the sexual assault. *Smith v. State*, 270 Ga. App. 826, 829(2), 612 S.E.2d 97 (2005). Although Georgia law provides that a defendant may not be convicted upon the uncorroborated testimony of an accomplice, former O.C.G.A. 24-4-8 (see now O. 24-14-8), the evidence here corroborated some particulars of the accomplice's testimony implicating the defendant in the crimes of which the defendant was convicted, and as stated above, the corroboration was sufficient to authorize the jury's determination that the defendant was guilty beyond a reasonable doubt as a party to the offenses, *Martinez v. State*, 278 Ga. App. 500, 629 S.E.2d 485 (2006). The accomplice testified that the defendant and his codefendant were members of the Trojan street gang and had invited the accomplice to join the gang; that the accomplice joined the gang and the codefendant pointed out the defendant's house for the accomplice to visit; that the defendant suggested that the accomplice rob a different gas station and that the codefendant and another gang member provided that accomplice with two guns that they had stolen; that the accomplice, the codefendant, and the gang member attempted to steal a third car but were unable to do so; that the defendant accompanied the accomplice and the codefendant to the gas station where the third car was to be taken and the robbery was to be committed; that the defendant waited in the car while the accomplice and the codefendant went into the gas station for the actual robbery; that the codefendant pointed a gun at a woman who worked at the gas station and demanded that the accomplice rob the woman; that the accomplice took money from the woman; that the accomplice, the codefendant, and another gang member forced the woman and a man to lie down on the floor and that the codefendant "went down there and raped her"; that the accomplice and the codefendant then drove to another gas station where the accomplice forced the driver of that car to lie down on the floor and robbed the driver; that the accomplice and the codefendant then drove to the third gas station, where the defendant waited in the car; that the accomplice and the codefendant robbed the driver at the third station and forced him and another man to lie down on the floor; that the accomplice, the codefendant, and another gang member drove to another location and attempted to steal a fourth car but were unable to do so; that the accomplice, the codefendant, and the gang member then drove to the gas station where the accomplice had first robbed the woman; that the accomplice and the codefendant robbed the woman again at that station and that the accomplice forced the woman to give them money; that the accomplice returned to the third gas station with the money he had collected from the woman and gave some of the money to the codefendant, who took it; and that the codefendant and another gang member left in the third car, which was stolen, but returned and loaded the third car with stolen items, which they took away.
